Payment Terms

All payments must be made in full prior to the commencement of the Conference.

Cancellation/Modification Terms

Cancellation Policy

All cancellations are subject to the following cancellation fees, based on the date the written cancellation request is received by the Conference organizers (including in the event that the contracted sponsorship fee has not been received):

- Up to 90 days or more prior to the start of the Conference: Free Cancellation.
- 60-89 days prior to the start of the Conference: Cancellation fee in the amount of 70% of the contracted sponsorship.
- Less than 60 days prior to the start of the Conference: No refund and the full sponsorship amount must be paid

By signing the Sponsorship/Exhibition Agreement, the company acknowledges and agrees to the payment and cancellation terms set forth above.

General Conditions
